How to Fill In & Sign This PDF Form Using Adobe Acrobat Reader

This PDF form can be filled in, signed, saved and emailed to the Kono Tayee Secretary by following these steps:

- Using PDF forms requires a software called Adobe Acrobat Reader. Most computers have this program installed. If you do not, you can download it for FREE here.
- Once you know you have Acrobat Reader, click on the Kono Tayee form you want to complete to open it. Then save the PDF file to your computer.
