## 1.) Present at Meeting

## 2.) Call to Order/Opening of Meeting

John McCloskey called the meeting to order at 10:00 am and led the members in the Pledge of Allegiance. Board members present included John McCloskey, Jim Hiss, Sarah Glenn and Tom Atteberry. John announced 4 Board members present, we have a Quorum. Debbie Pryor was absent, at a memorial.

## 3.) Approval of minutes from February 2<sup>nd</sup>, 2019

Jim Hiss made a motion to approve the Minutes from the February 2<sup>nd</sup>, 2019 meeting. Tom Atteberry seconded the motion and it was approved by all.

# 4.) Minutes from Executive Meeting March 9<sup>th</sup>, 2019

Tom Atteberry read the minutes of the Executive Meeting March 9<sup>th</sup>, 2019. Present at the meeting, John McCloskey, Jim Hiss, Debbie Pryor, Sarah Glenn and myself.

a. Crime coverage policy and the cost of the CPA audit

Debbie Pryor made a motion to accept the insurance bid from R.C. Fischer & Co for the Crime Coverage policy with a cost of \$623.00. Jim Hiss seconded the motion and all were in favor.

#### b. Road repair cost increase

Sarah Glenn made a motion to increase the expenditure of the Road repair items 1 & 3 from Valley Paving to a total of \$15,880.00 due to the price increase from previous proposal which had expired. Jim Hiss seconded the motion and all were in favor.

#### c. Lien on lot 9

Jim Hiss made a motion to spend \$500.00 more totaling \$1,250.00 to have the lien written by the Attorney. John McCloskey seconded the motion and all were in favor.

#### d. Docks in Parcel B

Debbie Pryor made a motion to spend \$1,000.00 for Attorney's help in writing a letter to Lysenko. Jim Hiss seconded the motion and all were in favor.

#### e. Budget committee review

Debbie Pryor informed the Board as to what was discussed at the Budget Committee Meeting. New expenses along with increased expenses will create an increase in the yearly dues. The Budget Committee proposed an increase in next year's Dues for Board consideration.

#### f. Adjournment

The meeting ended at 12:25 pm Sarah Glenn made a motion to accept the minutes. John McCloskey seconded the motion and all were in favor.

#### 5.) Annual Policy Statement, Powers and Duties of the Board

the Homeowners that own property on Richard Dr. extension to get the dirt removed and some kind of barrier to prevent any dirt or debris on the road.

#### 11.) Thanks to everyone that helped move the Docks



#### 13.) Resident's questions and comments

Weeds are growing with all the rain we have gotten this year. Weed inspection will be starting and finish by mid-May. Comment was made regarding the residence near the end of Cora Dr. is still an eyesore. Items should be removed and or stored in a fashion not visible. Comment was made regarding Parcel B being centered or opened up at the end of the canal. The problem being if the property lines are moved some property owners would lose property as others would gain. A variance was asked if it could be a compromise, unfortunately if one variance is granted then others will ask for one and would get out of control. Comment was made regarding dredging the canal. Unfortunately the estimated cost of dredging is \$150,000.00. In order to raise the money for dredging this might require a special assessment. Comment was made regarding when a member is fined. The Board needs to establish a How to pay a fine policy defined in our By Laws.
