Call to Order/Opening of Meeting

Mike Morarity called the meeting to order at 12:00 pm, and thanked everyone for coming. Mike Morarity led us in the Pledge of Allegiance. Board members present included Mike Morarity, John McCloskey, Debbie Pryor and Jim Johnson. Mike Morarity announced that a quorum was present.

Minutes of Previous Meetings

Debbie Pryor stated that the January 10, 2017 Board Meeting Minutes will be put on hold, revised, and added as an agenda item at our next Board meeting. The January 10, 2017 Board Meeting Minutes will be revised to remove names of specific owner comments, as recommended by Robert's Rules of Order. The Board reminded those attending the meeting that Kono Tayee maintains an open forum for board meetings, where member input and discussion is welcomed. General comments were made from those present about the benefits of including names as reference of opinions. Mike Moriarty reminded attendees that the primary purpose of the minutes is to reflect what the Board discussed and decided at Board meetings.

Restructure of Existing Board Members

Mike Moriarty announced and accepted the resignation of President Bob Sulivan and Secretary Tom Atteberry. Mike Moriarty made a motion to move himself into the President position, move John McCloskey into the Vice President position, move Jim Johnson into the Director position, keep Debbie Pryor as Treasurer, and add Jeanne Wallenstein as Secretary. John McCloskey seconded the motion and all approved. The Board decided to not fill the Alternate Director position. The Board is in the process of collecting documents and project status from Bob Sullivan, county officials, and various contractors.

Treasurer's Report

Debbie Pryor reported miscellaneous expenses including \$750 for the first payment of the beach survey, \$600 for asphalt removal at the Alston/Richard corner, \$325 for RB Pest Control, and postage and monthly maintenance costs. Debbie asked for a second \$750 check to be paid for the beach survey. Debbie stated that the Budget Committee would meet February 17, 2017.

Old Business

Brenda Reyes thanked those who contributed to the beach survey, and invited surveyor, Steve Bellah of Conser Land Surveying, to provide an update. Steve completed the preliminary record of survey, and will submit it to the Country Surveyor for review before the survey can be finalized and certified, and the new monuments set. Steve mentioned difficulties in completing the survey because of weather and because he could not find original monuments. There was some follow up discussion from members about possible knowledge of available monuments and photographs, indicating the location of original monuments. Steve anticipates the final, certified survey to be completed within 1-2 months. He reminds residents not to remove or destroy any monuments (iron, rebar markers) found. Survey costs have exceeded the original contract amount. Survey donations are still welcome.

John McCloskey reported that the original contractor that was hired to remove the concrete patch at the corner of Alston/Richard returned the \$600 check and refused to do the work. Several other contractors have also declined to do the work. John will discuss this matter with the property owner and ask if he can do it himself.

Resident's Questions, Input and/or Comments

Brenda Reyes mentioned the Architectural Committee's preliminary discussions about wheel chair access to the pier at the barbeque area. Debbie Pryor suggested continuing the discussion as an agenda item at the next Board meeting, where it can be more fully discussed in terms of budget, ADA requirements, construction complexities, etc.

There was general discussion about the preliminary work the Architectural Committee is doing to review and revise the Architectural Rules for the new CC&Rs in a Phased 1 (update to current regulation), Phased 2 (proposed changes) approach. Discussion followed about the process that needs to take place to review and update the documents, seek feedback from the membership, and eventually go to the membership for a vote, requiring a 2/3 majority vote for approval.

Jim Hiss and Curt Beckwith thanked those who helped with the beach tree trimming, including: Curt Beckwith, Jim Hiss, Tony Marchese, Terry Hale, Joe and Brenda Reyes, Debi Cormack, Don Apedaile, Ross Calvert and Curt's granddaughter Amanda, Debbie Pryor and all those who supplied their green waste bins.

New Business

Mike Braley announced that the 2017-2018 election is coming up. Nomination forms will be mailed on April 10, 2017, and should be returned by May 16, 2017. Ballots will be mailed on May 30, 2017.

Adjournment

John McCloskey made a motion to adjourn the meeting. Debbie Pryor seconded the motion, and all approved. Meeting adjourned at 1:03 pm.

Any corrections to the report will be done at this time. Once approved Conser Survey will set the permanent property markers. At this time, we will know the exact dimensions.
