- Only one road in and out of the neighborhood
- The time frame for first responders, such as Sheriff and Fire Departments
- The lack of an emergency response phone system that calls County residents in case of an emergency.

These are just a few of the points I brought to their attention.

The hope will be for the County to get Federal Government funds to increase emergency preparedness in Lake County.

The lake level is at 5.65. There is a lot of debris in the lake. Please be careful when boating. If you have a dock, you should check it for trees and limbs, which could damage your dock and/or pilings.

#### Present at Meeting

#### Call to Order/Opening of Meeting

President Bob Sullivan called the meeting to order at 10:07 am, thanked everyone for coming. He welcomed Mike Morarity as the new Vice President. Bob Sullivan led us in the Pledge of Allegiance. Board members present included Bob Sullivan, Mike Morarity, Jeanne Wallenstein, Ernie Lee and Jay Greenwell. Debbie Pryor was absent and excused as she had a service to attend. Bob Sullivan announced that a quorum was present.

#### Minutes of Previous Meetings

Hearing no changes or corrections to the September 8, 2012 Board Meeting Minutes, Jeanne Wallenstein made a motion to approve them. Mike Morarity seconded the motion, and the motion was approved.

#### New Association Website www.konotayeeestateshoa.com

Jeanne Wallenstein mentioned that the new Kono Tayee Estates website was launched in October, 2012, and has received positive feedback from the community. She discussed what the website includes and asked for comments and feedback from those present at the meeting. Bob Sullivan mentioned that our website has been an easy resource for directing prospective property owners. He also mentioned that the Lake County link from our website can take you to a listing of recent health inspections for local restaurants, hospitals, and businesses. Jeanne Wallenstein made a motion to approve the \$19.99/month (\$240/year) cost to host the website. Mike Morarity seconded the motion, and the motion was approved.

#### Treasurer's Report

Bob Sullivan announced that the Board has a copy of the current Treasurer's Report, which shows the financials through December 31, 2012. There is a total of \$102,345.29 in our accounts. Expenses are in line since Debbie Pryor's last report, but members can contact Debbie directly with any specific, additional questions. Bob Sullivan made a motion to approve the Treasurer's report. Ernie Lee seconded the motion, and the motion was approved.

#### President's Report

#### Item 1: Dockwalker Induction

Bob Sullivan, representing Kono Tayee, was inducted into the 2012 Dockwalker Hall of Fame. Bob talked with about 40 boaters at a Kono Tayee barbecue last year, promoting clean boating practices and distributing boating kits. The Dockwalker Program is led by the CA Coastal Commission and the CA Department of Boating and Waterways.

#### Item 2: FEMA Emergency/County Assessment Report

Bob Sullivan, representing the Association as Board President, recently met with the California State Department of Public Health to discuss how well Lake County residents are prepared for a disaster. The Agency provided pamphlets to Bob, which discussed home emergency preparation, including recommended inventory of supplies and equipment, which should be kept in the home.

He discussed several needs critical to the Kono Tayee area with the Department:

- The development of more than only one road in and out of the neighborhood
- Improved response time for emergency personnel such as Sheriff and Fire Departments
- A county-wide emergency response phone system
- Direct access to Red Cross, and
- Sufficient food and gas supplies

#### Vice President's Report

Item 1: Shoreline Weed Control

Mike Morarity and Bob Sullivan plan to meet with the County before the April 2012 Board Meeting to discuss weed control along the Kono Tayee shoreline. Costs would include spraying by a vendor and permits. Obtaining a "Master" permit for the whole shoreline would be less expensive than one for each property. Mike mentioned several options and discussion topics, including:

- Obtaining County funds
- Increasing Association dues to cover costs either for all membership or just waterfront owners
- Health issues related to the bites caused by insects in the weeds
- What other communities have done, and
- After failure of the 2012 tax initiative, it is unclear whether funds for weed control will be available this year.

Weed abatement in the canal is currently paid for (approximately \$3,000 annually) by the Homeowners Association under 1 permit, as stated in our CC&Rs. Last year the County paid to have the beach area sprayed.

#### Social Committee Report

Mike Braley announced that the Summer Community BBQ dates are June 8, July 13, August 10 and September 14. Oktoberfest will be September 28th (provided by the Cassin Family).

The December 8<sup>th</sup> Christmas Party, hosted by the Corsini Family, was a great success. Food and monetary donations were given to the Lucerne Senior Center. Bob Sullivan thanked the Corsini's for putting on such a nice event. The date and host for the 2013 Christmas Party has not yet been set, but will be announced soon.

#### Sunshine Committee Report

In Nancy Piazza's absence, Ernie Lee reported that Get Well cards were sent to Don Robertson for the loss of his father and for his recent surgery.

AT&T is currently working in our Community to install underground fiber optic cable. AT&T has been delayed because existing County records do not clearly indicate the location of water and sewer pipes. This project involves multiple agencies, including Lake County Public Works, AT&T, Lake County Special Districts, and a contractor. Bob will contact AT&T to clarify if they are installing wire or fiber optics.

#### **Questions and Comments from the Community**

Lynn Morarity asked if there was any recent news about the Konocti Resort. No news has been announced.

Vyonne Burrows asked about installing new 5 mph floats. Bob Sullivan noted that a few new buoys will be purchased and installed in the Spring. Bob will talk with the County about installing an illuminated buoy at Kono Tayee Point for navigation purposes.

Bob Sullivan mentioned that the Architectural Committee will be working on a list of standardized rules for architectural review process in our community.

Bob Sullivan mentioned that he will be working with the Architectural Committee to improve the entrance into our community.

Ernie Lee suggested replacing the light bulbs at the new entrance sign, and suggested talking with AT&T about leaving conduit so we could install lighting for the Kono Tayee entrance sign.
