## PRESIDENT'S REPORT

January 11, 2014

The windstorm of November 21<sup>st</sup> and 22<sup>nd</sup>, 2013 created a large sand bar at the mouth of the canal, which was about 1 to 2 feet higher than the water level and about 25 to 30 feet in width. In my 30 plus years in Kono Tayee, I have never seen such a blockage at the canal.

The Board called an emergency board meeting to discuss the canal blockage on December 29, 2013. It was decided by a unanimous vote to hire a dredging company at a cost of \$15,100.00 to have the mouth dredged. In years past, we have piled up the dredged materials right at the mouth against the owners retaining walls. This seemed to part of the problem, as we have piled so much up at the mouth it fell back into the canal. There are adequate materials at the base of the retaining walls to provide protection to their footings. This time we moved the excess material back away from the mouth area. By doing this we also restored the canal to the original design grade at the inner lots.

Rumors were spread that the Board was spending \$20,000 on the work. Not True! The contract was \$15,100.00. I negotiated an extra day of work at no charge, a savings of \$2,900.00. Whenever any member has questions about Association-related matters, please feel free to contact me. Rumors can be disruptive and cause separation in the community.

I was hoping not to have to deal with the dredging this year. It was the last thing I wanted to deal with this year. I am working to form a canal committee to discuss a more long-term solution. We will look into consulting an engineer and other experts.

This was unfortunately a "perfect storm" - the very low water combined with high winds hitting the canal mouth at just the right angle. The large waves pulled sand from the bottom out past the mouth in much deeper water and pulled the sand from the sides and dumped it in the canal.

We also installed some materials at the launch ramp to help minimize the steep drop off. This cost was included in the dredge bid. John and Debi Cormack, and a little help from me, spread some sand on the beach area where some erosion occurred due to the winds. Be very careful when launching any boats as the ramp is steep and short. It might be best to wait until the lake comes up a bit.

In total, we got a lot done for the dollars spent. We hope it will last much longer this time.

This Board has always kept our members aware of our actions, and listens to all comments from the membership. In years past, the board agendas for regular meetings were only posted at the P.O. Box area. Now, we not only post the agenda, but we also send them out via e-mail in advance to about 80 owners.

The trees at the beach are being pruned in a manner to form a canopy to provide shade for the beach tables. The trees will be a little shorter and wider.

Bob Piveronas, a part-time boat patrol deputy, was shot and killed in December while off duty. Bob and Bill Ellis were good friends for many years, as they both were avid pilots. He was also the boat deputy that has responded to many calls in our area for assistance. He will be missed.

The lake level is at .60 above zero. This is the lowest level in many years. Let's just hope we get rain soon!

#### Call to Order/Opening of Meeting

Pres. Bob Sullivan called the meeting to order at 10:00 AM, welcomed those in attendance, and led the Pledge of Allegiance. He also announced that a quorum was present.

## **Minutes of Previous Meeting**

#### **Treasurer's Report**

Debbie Pryor reported that the total in both checking accounts is \$95, 478.88 and \$276.64 in petty cash as of December 31, 2013. (Account balances and banking summary are attached.) There were no major expenses from September to December, 2013 other than one insurance policy renewal. Debbie said that at the end of March she will have updates for the Budget Committee, whose members for 2014 are Jim Hiss, Debbie Pryor,

Bob Sullivan, Tony Marchese, and Craig Courtemanche. A motion was made and approved for acceptance of the treasurer's report.

#### **President's Report**

#### 1. Storm Damage:

A severe windstorm came through from Paradise Cove to Upper Lake during the week of November 20-24, 2013. Winds were clocked between 60-80 mph. and it was considered as a tornado. Damage was extensive, with Nice taking the brunt of it. The county preliminary damage estimates were \$6 million but will probably be closer to \$12 million. Here in the community 10-12 roofs were damaged, tree limbs snapped, doors and windows broken, and power was out for 3 days. In addition, there were 2 fires close by caused by downed power lines......luckily houses were saved. The pier awning supports came loose along with the bolt on one of the pilings, which John Cormack and John McCloskey did temporary repairs on during the storm. Afterwards, John

McCloskey constructed new bracing supports for the awning and repaired the benches at a cost of \$800.00 John & Debi Cormack will continue with their project to add additional nuts/bolts to the pier bracings and pilings to further secure them as the weather permits.

#### 2. Canal:

By far, the worst damage to the community was to the canal, where a huge sandbar formed at the entrance and blocked the flow of water. This causes the problems of stagnant water, fish die-off, a mosquito danger when the weather warms, and a lack of access for boat traffic. After discussions, it was deemed to be an emergency situation and an emergency meeting was held on the 29<sup>th</sup> of December, 2013 to decide the course of action. A bid for dredging had been obtained at a cost of \$15,100.00 and it was decided that the emergency dredging needed to be done. A motion was made and unanimously approved to contract the work to be completed the week of Jan. 6-10, 2014, with the excess sand moved away from the mouth further back into the canal and the funds to be transferred from the reserves account to cover the expense.

## 3. Mussel Stickers:

There is now a state fee of \$16 for a mussel sticker. None of this goes to the county, which requires its own \$10 mussel sticker and enforces compliance. Any boat in the water, within 50 feet of the water, or within 150 feet of a launch ramp is required to have one.

#### 4. Garbage Bags:

The purchase and sale of garbage bags was discussed. A suggestion was to ask that residents buy their own or subscribe to trash service. The community cans are only for community event use, but are being used by some residents for personal use. A method of securing them will be explored. Further discussion will take place to decide on the action to be taken.

## **Architectural Committee Report**

Bob Sullivan gave the report:

- 1. People were notified of problems with their properties and compliance has been pretty good.
- 2. The committee was also involved with the dredging issue and decision.

## **Water Committee Report**

On behalf of the committee, Bob Sullivan reported that a notice to conserve water was sent out by the County to all residents. Also, our wood water tanks up at the top of Bruner Drive are being demolished for the construction of a new steel tank by Special Districts.

## **Social Committee Report**

Bob Sullivan reported in Mike Braley's absence the dates for the 2014 Community BBQs. They are June 14<sup>th</sup>, July 12<sup>th</sup>, August 9<sup>th</sup> for the Chicken-Q, Sept 13<sup>th</sup>, and September 27<sup>th</sup> for the Oktoberfest. All are at 5 P.M.

## Resident's Questions, Input, and Comments

- 1. The majority of the residents' input concerned the dredging of the canal.
  - A . Jim Hiss read a statement which questioned the process of an emergency meeting, asked for the formation of a long-term plan, discussed the cost of on-going dredging of the canal, and requested other construction options be examined.
  - B. A discussion took place during which various members made these points:
    - a. The canal is an important asset to the community, as are the other common areas and amenities.
    - b. Its maintenance is the association's responsibility and negatively affects property values for the entire community if a state of disrepair is allowed to happen. Also becomes a health and environmental issue (example is the Keys in Clearlake Oaks).
    - c. There needs to be more involvement of the membership concerning information.

- d. A long-term and more permanent solution to continual dredging should be explored. Some suggestions were the construction of a second wall, altering the entrance, or formation of a breakwater
- e. It was suggested to form a Canal Committee to study the issue.
- 2. It was asked if there is a standardized policy for the beach trees. The current decision is to canopy them for shade in the summer, with the desire to make that the future policy.
- 3. A question about the decision appeal process and method of paying fines was referred to the Davis-Sterling Act website for research.
- 4. A positive note was a compliment on the beach area, noting that the improvements are being enjoyed.

# Adjournment:

A motion was made to adjourn the meeting by Jay Greenwell and seconded by Mike Morarity. The motion was approved and the meeting adjourned by Bob Sullivan at 11:30 AM.
