PRESIDENT'S REPORT JANUARY 2015

Kono Tayee resident opens O'Meara Bros. Brewing Company. Alex and his brother, Tim, opened a Brew pub at 901 Blevins Street in Lakeport. The brew pub is a fusion of craft brewery and restaurant. Congratulations to them both!

Just prior to our July 2014 election I asked Terry Hale to take over the duties of inspector of elections when Pat Ridgel had to step down after he announced he was running for President of the Board. The committee did a great job with very little notice.

During our September Board meeting, Vice President Jim Hiss requested that our election votes be recounted due to a possible discrepancy in the reported count. Considering the election results overwhelmingly elected the Board and officers, I saw no need to recount the votes. If this is to be insisted upon, it should be carried out in compliance with California State Law described in the Davis Sterling Act. A committee did perform the recount, disregarding the requirements of the California State Law and the Davis Sterling Act. Unfortunately, this has created some division among our members and suggests an atmosphere of distrust concerning the conduct of the election. If anyone has any questions, comments or suggestions concerning this issue, I'm happy to discuss those issues at any time.

Our neighbors at Paradise Cove and Paradise Valley have a grant to pay for about 75% of the cost to connect to the Clear Lake Oaks water system. It is not finalized yet, as they still have some things to work out.

According to Mark Dillinger of Lake County Special Districts, Kono Tayee has a 2% improvement in our well level from last year. Our water consumption is down by 40%. However, it is important to know that the drought is **not** over. We are still 10-15 inches away from having a "normal" rain year. Keep up the good work on saving water!

VICE PRESIDENT'S REPORT

Davis Stirling Act

Davis Stirling Act & Residents' Committee. I asked each committee member to speak at the January Board Meeting regarding their perspective on restatement (incorporation) to Davis Stirling. The committee has met three times and considerable discussion has been generated as to need, timing, cost, process, enforcement, and voting procedure for the restatement of our documents into the Davis Stirling Act. Also, an attorney specializing in HOA was asked and he presented a written proposal of \$4,500 dollars for meeting with association representatives, initial drafting, review, voting draft, and assistance throughout the voting process.

After the members' report a Board Motion was discussed and passed that the committee will contact members via email and/ or telephone about an informational/educational general meeting to discuss "Restatement of the KTHOA documents". The purpose would be to inform and answer questions regarding Davis Stirling. This meeting would be held prior to the next Association Board Meeting.

MINUTES OF KONO TAYEE HOMEOWNERS ASSOCIATION BOARD MEETING

Held at the Beckwith home, 7894 Richard Dr., on January 10, 2015 at 10:00 AM

PRESENT AT MEETING

CALL TO ORDER/OPENING OF MEETING

Pres.. Bob Sullivan called the meeting to order at 10:01 AM welcome those in attendance and led the Pledge of Allegiance with four board members in attendance, he announced we have a quorum.

MINUTES OF PREVIOUS MEETING

Jim Hiss made a motion that the minutes of the previous meeting be read, there was no second. Jim requested that we discuss the election results of the July 5, 2014 meeting. There was an error in publishing the count but it did not change any results. Jim made a motion to except the September 13, 2014 minutes, Tony Marchese seconded the motion. The motion passed three for, one opposed (Bob Sullivan opposed the recount).

The Secretary will send out the new 2015 mailing list in January.

TREASURER'S REPORT - Tony Marchese

Tony Marchese gave the current financial report. The total for all accounts as of December 31, 2014 is \$90,883.17, with \$15,182.06 in checking, \$75,494.23 in reserve and \$206.88 in petty cash. The major expenses during the period from July 1 to December 31, 2014, were Insurance for \$6,097.00, and Maintenance for \$2095.91.

Jim Hiss wanted to discuss the reserves for dredging. The board decided to wait until Debbie Pryor, treasurer, was available the question that Jim wanted to ask was, "How much is actually in the reserves for dredging?".

Jim made a motion to publish the "Itemized Category Report", which lists each Association expense since July 1, 2014. There was no second. Jim is going to post the full treasurers report on the community bulletin board for two weeks. No motion is required, as he is doing this as an individual.

PRESIDENTS REPORT - Bob Sullivan

A. Bob Sullivan said the docks are in good shape. Still a little drop off at the base of the ramp. There's a lot of large debris, large trees, parts of houses in the lake. The county is trying to pick up the smaller items – so be careful.

B. Thank you to Bill & Lorna Lawver for hosting a wonderful Christmas party.

C. PG&E were working on the trees by the mailbox. They did a nice job and also cleaned the area.

D. The blue awning on the dock came loose on one corner. The awning company fixed it at no charge. They said someone probably got a hook caught in the awning and cut it loose.

E. Tony Marchese found a leak at the corner of Milos and Cora Drive on the vacant lot. Bob Sullivan and Tony inspected the break. The gardener fixed the leak, two men and a total of five hours at a cost of \$145. The job was more extensive, as the pipes kept breaking because of their age.

F. Muscle stickers are due for the year 2015. The sheriffs office is zero tolerance, they don't give warnings, and it is a \$100.00 ticket.

G. The light at the barbecue area went out. John Mccloskey fixed the light, and charged one hour of labor. Thank you to the Ridgel's for reporting this.

VICE PRESIDENT'S REPORT - Jim Hiss

A. Ernie Lee and Jim replaced the light on the Kono Tayee sign at a cost of \$39.00. Ernie and Jim replaced the bolt on the swim platform to secure the chain around the piling. They also fixed the eye bolt. Jim want to stress that the repair was necessary, but was not a hazard. Jim also pulled out the swim buoys.

B. Davis Sterling Act – There have been three committee meetings since September 2014,

they discussed the merging of the Davis Sterling act with the Kono Tayee CC&R's. The Davis Sterling act is the law of California, and it trumps any and all CC&R's. There was a discussion about what to do, how to do it, and the costs the Association would have to pay to a lawyer. BOB SULLIVAN said that our current CC&R's have a lot of incorrect code numbers and vague statements. He is in favor of updating the CC&R's first, then to incorporate them with the Davis Sterling Act. TOM ATTEBERRY thinks we need an index to our CC&R's, and enforce the rules we already have. TONY MARCHESE questioned whether the \$4,500.00 would be well spent. He thinks that we should use our CC&R's, and then the Davis Sterling Act as needed. He also reminded the Board that it takes a 2/3 majority to pass any changes to our CC&R's. He said that Buckingham adds the changes as needed, they hire a lawyer each time at a cost of \$300.00, and still need a 2/3 majority to enact any changes.

PATRICK RIDGEL states that the Davis Sterling Act is the law of the land. He stated that some residents want to change our documents to reign in the Kono Tayee Board. Also, he stated that not incorporating the two documents puts our Association at risk. JIM HISS said that without having a lawyer's input, are we sure that it would/could be correctly completed by our Association. He doesn't feel comfortable working without an attorney. Also, he doesn't think a "piece meal" fix would work. YVONNE BURROWS questioned the cost. JIM HISS HEADS THIS COMMITTEE AND ALL THE PEOPLE THAT HAVE SPOKEN ARE EITHER ON THE COMMITTEE AND/OR A BOARD MEMBER.

JIM HISS AND THE COMMITTEE want to have an open meeting to discuss the Davis Sterling Act and our CC&R's. Bob Sullivan made a motion, seconded by Jim Hiss. The motion passed three to one. Tony Marchese opposed. The committee will pick the date, time and place. The owners will either be notified by email and/or telephone of the meeting and agenda.

CANAL REPORT - John McCloskey, Tom Atteberry, Bob Sullivan

John McCloskey reported that we are 2.8 feet above Rumsey Scale. The canal looks pretty good. John also brought photos and maps for members to see. Bob Sullivan notified an owner of his dock breaking loose. Also, Bob notified an owner of their sea wall having a crack.
