PRESIDENT'S COMMENTS JULY 16, 2015

Due to my vacation schedule I was unable to attend the General Meeting and election on 07/11/2015. This was the first meeting I've missed in many years.

A big thank you to Jim Hiss for running the meeting in my absence. I echo all the thank yous he mentioned.

Thank you, to all those who have has the confidence in me and for voted for me. Your support is appreciated.

I'm planning on hosting a neighborhood get together in the next few weeks. All the community is invited. The location, time and date TBA. This is not a board meeting. (A town hall meeting if you will) I'm looking for your comments and suggestions.

The missing buoys will be placed the week of 07/20/2015. I installed new decals and cleaned the old buoys. No need at this time to purchase new ones.

The 4th of July weekend was the busiest and best ever. Thanks to all that made it happen.

I have received concerns about residents parking on other owners properties as well as other parking issues. Please note the following as stated in the by laws page 19 of 23. Due to importance of the issue I have included a shortened version of the rules below.

1. Owners of undeveloped property may store no more than two of their own (vehicles or trailers) on their own property for longer than two weeks.

2. Owners may store more than two vehicles and/or trailers for a short period, not to exceed two weeks.

Owners may give permission to another member or members to park non-owner vehicles on their property under the same guidelines and limitations as specified above. Any long-term non-owner authorized use shall be authorized in writing and such authorization be on file with the Association Secretary. Failure to notify Secretary may result in such non-owned vehicles being towed away at owner's expense.

a. Members are advised that they may be held liable for damage to non-owned vehicles stored on their property and for injuries caused by those vehicles.

b. Recreational Vehicles (RV's) or travel trailers may be used for additional sleeping quarters provided they are parked on property owned by members that is upon or adjacent to the member's Kono Tayee Estates residence for a period not to exceed two (2) weeks.

a. Tenants do not have this privilege.

b. All vehicles parked within Kono Tayee Estates shall be in compliance with Section 10.205 of Division II of the Uniform Fire Code.

1. Section 10.205 states that: No vehicle, motorized or non-motorized shall park on any street in such a manner as to be an obstruction to the operation of any emergency vehicle.

2. There shall be no overnight, or extended non-attended daytime parking of any motorized or nonmotorized vehicle on Alston Way, Kono Way, or Harry Way.

c. Section 10.204.(a)of the Uniform Fire code States that : Fire apparatus access roads shall have an unobstructed width of not less than 20 feet and an unobstructed vertical clearance of not less than 13 feet 6 inches.

1. No trailer or boat may not be parked on any street overnight that is not connected to a vehicle capable of moving such trailer in an emergency.

2. Vehicles parked so to block access to emergency vehicles may be cited or towed at owner's expense.

The Architectural Committee has been busy reviewing applications for many improvements. Thank you, to the owners for their investments in our community.

The North dock gang plank was rebuilt by Curt Beckwith for only the cost of the materials. Great job by Curt. Does anyone feel the urge to host the Christmas party? Want to serve on a committee? Contact me for more information.

The storage lot at the end of Milos Ct. is not part of Kono Tayee. Please do not trespass or let your dog's enter the property. This includes the incline area that some think is a launch ramp.

Lake County has a leash law. ALL dogs must be on a leash and under control at all times. Please pick up after your pet.

Kono Tayee is a great place. Let's all work together to make it even better.

CALL TO ORDER/OPENING OF MEETING

Vice-Pres. Jim Hiss called the meeting to order at 10:00 A.M., welcomed those in attendance and led the Pledge of Allegiance with 4 Board Members present, 26 members present, and +-100 votes cast, Jim Hiss announced we have a quorum.

Vice-Pres. Jim Hiss, stated that he is going to change the agenda slightly. He called upon Patrick Ridgel, Elections Chairman, to address the members. Patrick Ridgel asked if there were any ballots that needed to be turned in, he also asked if anyone present did not receive a ballot.

Jim Hiss wanted to acknowledge the work that both Patrick and Becky Ridgel do for the Election. Also Mike and Judy Braley, for their help with the election. The Braley's, also, clean the picnic area before each event. Thank you to all.

MINUTES OF PREVIOUS MEETING

Tony Marchese made a motion to approve the minutes of the April 4, 2015 board meeting, seconded by Debbie Pryor. The minutes were approved as written.

TREASURERS REPORT

Debbie Pryor gave the current financial report. The total in all accounts is \$83,068.04, with \$7,337.22 in checking, and \$75,531.54 in reserves, and \$199.28 in petty cash, as of July 1, 2015. The transfer of funds to the reserve account will be on the Agenda for the September 2015 Board Meeting? Some of the expenses for the last quarter are: Landscape, Professional fees, Postage for election, Web site \$358.00, Dock works \$814.74. There was a donation from Stan and Cindy Ochoa for the luncheon during Community Clean-up Day.

Tom Atteberry asked about Debbie's statement of putting aside \$2,500.00 for the Davis Sterling Attorney. Jim Hiss explained that Debbie was trying to be prudent in the finances. And that money can not be spent without board approval. (Account balances and banking summary are attached to the minutes.)

Bob Sullivan gave this report to Carol Beckwith to read at the meeting:

I want to thank all the Committee and Board Members for serving the community.

The gang plank on the north side of the launch ramp was re-built by Curt Beckwith. The material cost was \$814.74. Curt donated his labor (at least 3 to 4 days), he also got some materials donated. Thanks to Curt for stepping up.

Celeste Feldman still wants to know what the community needs to do to get an answer regarding the use of the barbecue area. She was under the assumption, that the umbrellas and picnic area could be used on the Fourth of July. She would like to have the 4th designated a Community Holiday and/or Community Event.

Brenda Reyes wanted to know if a family reserved the barbecue area, could others also use it. It was stated that there are only 3 to 4 weekends that are really busy, and it has never been an issue. Everyone shares. Jim Hiss says we need a written form for expectations, rules, etc., and that after one year the Board evaluates the residents comments. And make adjustments as needed.

Nash Piazza said people need to ask permission of the owners of the buoys. Mary Lou Milbourn said there is a 5 mile per hour buoy missing.

Sara Glenn asked if anyone had any expectations how long the pier would last. She wanted to know if the Association was saving funds for future repairs or replacement. Jim Hiss said no one actually knows how long it will last, but that the association fixes it as needed. Naish said that our pier used to be the largest one in Lake County. Ciago is now the largest. John Cormack questions the quality of the pilings.

Debbie Pryor thanked the Beckwith's for the Fourth of July Slip and Slide. A thank you to the Glenn's for the face painting. The Wallenstein's for the piñata. Also, a thank you to Celeste and her family for cleaning the beach every morning. The kids and ADULTS had a wonderful holiday.

Ernie Lee wants to know why we stain the deck and don't use longer lasting products. He also has had trouble receiving election material.

Carol Beckwith asked Tony Marchese if the MINOR MAINTENANCE GANG, could or would consider replacing the screws and nails that have backed out on the wooden parts of the pier and walkways. Tony said he would check into the project and advise the Board.
