#### MINUTES OF KONO TAYEE HOMEOWNERS ASSOCIATION BOARD MEETING July 2, 2016

The meeting was held at the BBQ area, Kono Tayee, July 2 at 10:00 am.

#### PRESENT AT MEETING

#### 1. CALL TO ORDER

President Bob Sullivan called the meeting to order at 10:00 am.

#### 2. OPENING OF MEETING AND WELCOME

Bob Sullivan welcomed those in attendance and led the Pledge of Allegiance. With all Board members present, he announced we have a quorum.

#### 3. CALL FOR INSPECTOR OF ELECTIONS TO COUNT VOTE

There was a last call for Ballots for the 2016/2017 Board of Directors. Mike Braley and his team were excused to count the ballots.

#### 4. APPROVAL OF PREVIOUS MINUTES

Bob Sullivan motioned to approve the minutes of the previous meeting and it was seconded by Tony Marchese, and passed by all.

#### TREASURER'S REPORT Debbie Pryor

Debbie Pryor gave the current financial report for 2016 through June 30. The total in all accounts is \$90,440.96 with \$3,001.29 in checking, \$66.07 in petty cash, and \$87,373.60 in reserves. Our income increased by \$20.15 which consisted of interest income in our reserve account and sale of garbage bags. Our expenses consisted of miscellaneous association expenses (meeting room rental for April), landscape maintenance, office supplies, postage & printing (mostly for the election), briquettes for BBQ and beverages for clean-up day, buoys, spraying the canal, miscellaneous signs, and paint.

Homeowner Dues notices will be sent out in the next couple of weeks. Again, the dues will remain the same as last year: \$277 per lot. Please try to submit your dues early to avoid the cost to the association of the sending out reminder postcards.

Debbie Pryor made a motion to move the \$3000 in our checking account into the reserve account once additional funds from the collection of dues becomes available. The motion was seconded by Tony Marchese and passed by all.

Debbie Pryor mentioned that the board needs to continue to work on the association documents (CC&Rs, By-Laws, Rules and Architectural Rules) to have them completed so the community can eventually have a complete set to review. We've spent the funds this past year on them, the Davis Stirling Committee and Board spent a lot of hours on what's been done, but there is still more to go. It will be a benefit in the end for the entire community.

#### 6. PRESIDENT'S REPORT Bob Sullivan

#### **Presidents Comments:**

- a) The community really got a lot done on our Spring Clean-up Day April 30<sup>th</sup>. Fire hydrants, curbs, light poles, and hand railings were painted. We got a complement from the Fire Department on the fire hydrant painting (thanks Brenda Reyes and Debi Cormack). Thanks also to all that participated!
- b) Special Districts installed a new water meter at the post office box at no cost to us. The meter we had at the beach area that was not used was removed (the box is still there). We can have it installed at no charge to us at a later date if we need it.
- c) The canal was sprayed for weeds with association funds. The County has agreed to spray the boat traffic lane lake when the weeds show up.
- d) Two buoys were repaired two new buoys were bought. All were installed with the help of Kerry Shaver.
- e) The fire hydrants were flushed and tested by North Shore Fire Department.
- f) Reminder that no fireworks are allowed in Kono Tayee.
- g) Road repairs were done on Alston and Richard Drive.
- h) The bear is back- game wardens heard the bear behind Richard Drive extension. It was noted that black bears can smell 7 times better than a bloodhound. Please bleach your garbage cans and double bag the garbage. If you encounter a bear make noise- scream; don't turn your back on them.
- i) A throwable life ring is to be installed on the dock.
- j) Trailers without cars attached should not be on the street. This is an emergency response safety issue.

#### 7. RESIDENTS QUESTIONS, INPUT AND/OR COMMENTS

There was much discussion about property lines and specifically about the possible encroachment into the Beach area. The Architectural Committee approved the concrete work done by the Ochoa's. Sarah Glenn suggested that the property lines should have been addressed prior to the concrete being poured. Bob Sullivan said the Architectural Committee will review this again.

Diane Holden Ayala, the new owner on Alston Drive wants the road repair taken out on her property. Bob Sullivan said that Public Works is making that decision.

Celeste Feldman suggested that the placement of the 'No Lifeguard on Duty' signs were a safety hazard to children running on the beach. The board agreed and the signs were removed after the meeting and replaced so as not to be in the way.

#### 8. 2016/2017 BOARD OF DIRECTORS ELECTION RESULTS Mike Braley

Mike Braley reported the following:

There were 79 ballots returned. Two of them were unsigned, making them uncountable.

For President, Bob Sullivan received 66 votes and was declared the new President.

For Vice President, Jim Johnson received 29 votes and Mike Moriarty received 44 votes. Mike was declared the new Vice President.

For Secretary, Tom Atteberry received 67 votes and was declared the new Secretary.

For Treasurer, Debbie Pryor received 70 votes and was declared the new Treasurer.

For Director, John McCloskey received 67 votes and was declared the new Director.

The new Board will begin their duties on September 1, 2016.

#### 9. ADJOURNMENT

Bob Sullivan motioned that the meeting be adjourned. It was seconded by Debbie Pryor and passed by all. The meeting was adjourned at 10:45 am.
