The wild life in Kono Tayee is flourishing. We have a large number of doves, which we have never had. There are several wild turkeys, deer, otters, muskrats and eagles nearby. We even have for the first time ever a baby osprey. The quail population is really growing.

**REMINDER**: The speed limit in Kono Tayee is 15 mph. Please watch for children, our wild life, and pedestrians.

In July, the County sprayed the swim area at no charge to the Association, saving more than \$1,200.00. I am working with the County to get more participation in our aquatic weed control throughout our waterfronts.

PG&E is in the process of trimming trees near their power lines. They are also upgrading the lines.



# **Call to Order/Opening of Meeting**

President Bob Sullivan called the meeting to order at 10:02 am, thanked everyone for coming, and led us in the Pledge of Allegiance. Board members present included Bob Sullivan, Nancy Piazza, Debbie Pryor, Jeanne Wallenstein, Ernie Lee and Jay Greenwell. Bob Sullivan announced that a quorum was present.

#### **Minutes of Previous Meetings**

Hearing no changes or corrections to the July 7, 2012 Meeting Minutes, Bob Sullivan motioned them approved as stated.

#### Treasurer's Report

Debbie Pryor distributed copies of the Treasurer's Report, which showed the financials through August 31, 2012 (see 2 attachments). There is a total of \$110,611 in both of our checking accounts. Currently through the end of August, we have collected \$25,400 in homeowners' dues. There are 12 remaining lots that still owe dues. As of September 15<sup>th</sup>, the dues will be past due. Debbie Pryor will call and send follow-up notices to those with outstanding dues. There has been \$1,363 in recent expenses. Our reserves for the current fiscal year are \$12,669. Debbie made a motion to transfer \$6,669 into our reserve fund, which will leave a remaining balance of \$6,000 to be funded, and \$18,000 in our current checking account. Jeanne Wallenstein seconded the motion and the motion was approved. Debbie is waiting for our year end taxes to be returned by the accountant, and has rectified our corporate standings with the State. Nancy Piazza made a motion to approve the Treasurer's report. Ernie Lee seconded the motion, and the motion was approved.

#### **President's Report**

Item 1: Approval of Committees

Bob Sullivan recommended the following members to be appointed for the respective positions below:

- a. Jay Greenwell as Alternate Director
- b. Bob Sullivan as chair, Ernie Lee as co-chair, Dean Carlson, John Cormack and Jay Greenwell to the Architectural Committee
- c. Bob Sullivan, Debbie Pryor, Tony Marchese and Naish Piazza to the Budget Committee
- d. Headed by Naish Piazza, Ernie Lee, Bob Sullivan and Dave Wallenstein to the Sewer, Water and Roads Committee.

Additional Committees were appointed as follows:

- a. Nancy Piazza to the Sunshine Committee
- b. Mike and Judy Brailey to the Social Committee
- c. John Cormack as Keeper of the Flag

Jeanne Wallenstein made a motion for approval, and Debbie Pryor seconded the motion. All approved.

Item 2: Neighborhood Watch Program

The Neighborhood Watch Program has been put on hold until we increase interest and participation. The Sheriff's Department wants at least 10 couples to start the program.

#### Item 3: Approval of New Entrance Sign

The Architectural Committee is updating signs in the community. Bob Sullivan made a motion to replace the large "Caution: Children at Play" at the entrance with a new sign stating "Private Community, Residents and Guests Only. No Solicitors." Cost for the sign is \$370 from Sheldon's Signs in Lakeport. Nancy Piazza seconded the motion. Motion was approved. There was further discussion to add additional caution signs throughout the neighborhood for pedestrians and children and 15 MPH speed limit. Bob will work with the County to obtain these additional signs or the Board will purchase them for the community.

#### Item 4: Stepping Out Committee

The Board is looking for a new Chair to coordinate and set up community events for the Stepping Out Committee. If you're interested, contact Bob Sullivan.

#### Item 5: Launch/Dock Permits

Bob Sullivan reported that the Permit Program is working well for residents and guests. Bob has purchased revised permit passes, which are less costly, and are easier to display. He is now issuing dated, temporary passes to guests, instead of relying on our standard resident passes.

#### Item 6: Fire Prevention

Bob Sullivan reminded residents to take fire prevention measures. He reported that some residents have made an effort to maintain trees and excess brush and to water down their properties. PG&E will do some heavy pruning and maintenance. CALTRANS will also do some maintenance, mostly at the entrance to our community for sight visibility. Kono Tayee does not have a secondary exit (only secondary exit is via the water), so it is important to keep up on fire prevention and to maintain trees and brush. Residents can contact our local Clearlake Oaks CALTRANS personnel for broken tree maintenance from the highway.

#### **Vice President's Report**

#### Item 1: Mailbox Area Improvements

Nancy Piazza reported that she would like to improve the mailbox flower area. She will work with Dave Buttke to improve this area. Nancy is seeking volunteers to help with the project. She will obtain approval from the Board before any purchases are made.

#### Item 2: Christmas Party

#### **Social Committee Report**

Oktoberfest will be Saturday, September 29<sup>th</sup> at 5 pm at the beach area. There was a Community BBQ held on Saturday, September 8<sup>th</sup>.

#### **Sunshine Committee Report**

Get well cards were sent to Mike Morarity and Elizabeth Jones. A sympathy card was sent to Mattie San Filippo, for the loss of his wife, Marie.

#### **Water and Sewer Committee Report**

Naish Piazza reported that he has asked Mark Dillinger of Special Districts to notify him if there are any announcements regarding the Paradise Valley development. Special Districts sent Naish notice of a water line break on Bruner Drive in mid-August. The break did not affect our district.

#### **Architectural Committee Report**

Item 1: Status of Fall Inspections

Bob Sullivan reported that fall inspections will be held around October. He reminded residents to keep leaves cleaned up so we keep our storm drains clear. The Architectural Committee is keeping up on several reminder letters to residents.

Item 2: Status of Canal, Dredging Study and Weeds

A lengthy discussion was held about the maintenance of the canal. The canal was fully dredged in 2008. An attempt was made last year to remove material from the mouth to reopen the canal, but the material quickly moved back in. The design of the canal is problematic and requires frequent maintenance and dredging especially at the mouth. There was an open discussion about options for maintaining the canal including a secondary wall, purchasing dredging equipment, dredging frequency, and timing of dredging activities. The Budget committee will review costs for these options in future years based on the Architectural committees' responsibility to recommend when the canal needs dredging. The depth of the lake is projected to be 1.0 Rumsey by November 1<sup>st</sup> so dredging will be necessary to allow any boat access this year. Debbie Pryor made a motion to allocate up to \$5,000 to dredge the mouth of the canal this year, which would be funded from the reserve account. Ernie Lee seconded the motion. The motion was approved. The dredging was completed approximately 1 week after the meeting.

Lake weed conditions are particularly bad this year. The Board discussed various options for annual weed spraying and abatement. Bob Sullivan is working with the County to obtain a universal permit for community wide spraying. Debbie Pryor recommended that the Budget Committee review funds allocated to address annual spraying and weed abatement. There was some discussion that if multiple properties were sprayed at once the total cost would be cheaper. The County Invasive Species department has approved raking and cleaning of weeds in our beach area. The Board will continue to work with the County on control of weed growth and possibly obtaining public funds to pay for weed control.

#### **New Business**

Jay Greenwell suggested that the Association rent a dumpster for a weekend "anything goes" Cleanup Day. The Board will consider this and notify the community.
